Happy New Year to all our Shipmates of the Northwest Region.

The new year brings a few changes to the Fleet Reserve Association. We are a smaller force than we once were and many of the changes are predicated on that fact. The goal or object of the Fleet Reserve Association remains unchanged. Article 2, Section 201 of the Constitution and Bylaws: "Object of the Association – The object of this Association is that we may take care of such members and their families who may be in urgent need of assistance, financial or otherwise; to assist in recruiting for the United States Navy, Marine Corps, and Coast Guard; to assemble for social intercourse and keep ourselves informed on United States Navy, Marine Corps, and Coast Guard matters, whereby we may continue to loyally serve the nation and the United States Navy, Marine Corps, and Coast Guard."

Why do I highlight this? Just to say that none of the changes being made affect the goal or object of the Fleet Reserve Association. Changes are being made to make the association more cost effective and efficient. If you noticed in the latest FRA Today, the staff at national headquarters has been reduced by half. Please make sure you are giving them the appropriate support and patience in responding to questions. Run questions by your Branch Secretary and President before running them up the chain. If you have problems that can't be taken care of at the Branch, please notify RPNW or NW Regional Secretary/Treasurer. A couple of the changes that are most notable: (1) Membership in the Fleet Reserve Association is now open to all sea service veterans, officer and enlisted. For officers, no prior enlisted service is required. (2) Life membership dues increased on 01 January 2024.

December and January are always busy months. With the holidays, parties, family, and friends getting together. It is also when the yearly essay contest deadline passes and it is time to get the essays judged and into the regional chairman.

Now is a good time to start thinking about end of year reports. It is never too early. Start compiling data now so your Branch can have a good showing at the Regional Convention. We hope to see more of you in Kennewick in September. Plan now.

Regionally there have been changes in our Branches. When changes are made within the structure of the local Branch, make sure reports are updated and submitted as appropriate. Northwest Region now consists of 20 active Branches with approximately 1750 total members. Branch 310, Silverdale, recently merged with Branch 029 of Bremerton. Branch 342 has advised that they are in the process of surrendering their charter. If your Branch needs assistance in any way, please reach out.

There is no timeline on recruiting, retention, and membership. The Fleet Reserve Association needs a concerted effort to add to our membership rolls. We need to think about it daily if the association is going to survive. I shop at an Army Commissary and Exchange on a regular basis. It is a rare occasion if I don't run into a fellow sea service veteran. Show your colors when you are out and about. Invite them to your meetings. I haven't met one yet that doesn't like to hear the latest scuttlebutt.

2023 NW Region Convention Recap

The **2023 Northwest Region Convention** was held August 18-19, 2023, at the Holiday Inn, 16345 Merchant Way, Nampa, ID 83687.

One major change was made to the NW Region By-Laws: The PCT dues for each member in good standing of each Northwest Region Branch is increasing to 50 cents next year (an increase of 15 cents). We are awaiting the ratification of this change by the NBOD at the 2023 National Convention.

The 2024 Northwest Regional Convention will be held on September 6-7, 2024, at the Clover Island Inn located in Kennewick, Washington. It is being held later than normal since the 2024 National Convention won't be held until November to coincide with the FRA 100 year Celebration.

Inland Empire Branch 38, Spokane, WA will be coordinating with all the Northwest Branches to contribute their ideas into this convention.

Our idea is to make this a "true" northwest regional convention by having each Branch in the Northwest Region take responsibility for one of the activities that happen during a convention.

We were asked to step up and help since the Branch that was going to host in 2024 withdrew.

2023 National Convention Recap

Article 3, Section 301. Eligibility for membership in the FRA shall be for *ALL* personnel who have served or are now serving in the United States Navy, Marine Corps, or Coast Guard, including reserve components and regardless of length of services. *Resolved:* That this amendment become effective January 1, 2024

APPROVED BY VOICE VOTE

Article 3, Section 311(e)(7). The Fleet Reserve Association will provide the fifty through seventy-five year continuous membership pins to branches and individuals at no cost; and *Resolved:* that the above section be amended to read: "The five through seventy-five year continuous membership pins will be made available for sale to branches and individuals; and be it further *Resolved:* that Article 3, Section 311(8) be deleted.

APPROVED BY VOICE VOTE

Article 4, Section 401(a) and 401(b)(1)(2)(3):

Sets dues rate.

RULED NOT IN ORDER

Article 4, Section 401(e), pertains to disabled members being excused from payment of dues when payment would inflict hardship; and Whereas, the definition of disabled has been widely interpreted by branches;

RETURNED TO MEMBERSHIP FOR CLARIFICATION

Article 4, Section 401(m) states "Members in good standing, upon attaining eighty-five years of age and who have at least forty years' continuous membership, shall not be required to pay dues in the FRA and shall be issue the prestigious Red, White, and Blue Membership Card"; *Resolved*, that Article 4, Section 401(m) be deleted, and those members already classified as 85/40 members will be grandfathered to maintain their current status.

Resolved this amendment become effective January 1, 2024. **APPROVED BY VOICE VOTE**

Article 4, Section 405(a) pertains to life membership fees will be based on the applicants age at 12/31 in the year of application using the following eight tier fee structure:
