He is planning on holding a virtual event after the NBOD mid-year meeting to check in with all the regional branches on the progress in getting their reports submitted. # **2024 NW Regional Convention**

The 2024 Northwest Regional Convention will be held on September 6-7, 2024, at the Clover Island Inn located in Kennewick, Washington. It is being held later than normal since the 2024 National Convention won't be held until November to coincide with the FRA 100-year Celebration.

Inland Empire Branch 38, Spokane, WA will be coordinating with all the Northwest Branches to contribute their ideas into this convention. Our idea is to make this a "true" northwest regional convention by having each Branch in the Northwest Region take responsibility for one of the activities that happen during a convention.

Room Rates are \$114 per night plus 10.7% tax and \$3 Tourist Fee. These rates are good for September 4 to September 8, 2024. Reservations made after August 26, 2024, at this rate will be on space availability.

#### The 2024 (96th FRA/91st LAFRA) Convention

The Centennial Committee applied for and was granted by the 2022 National Convention delegates permission to host the 96th FRA/91st LAFRA Convention in conjunction with the FRA Centennial Celebration. The convention itself will be held at the DoubleTree by Hilton, 210 Holiday Court, Annapolis, Maryland, on November 10-16, 2024. The Centennial will be on November 11, 2024, and the Convention itself will be held November 12-25, 2024. Information is now available on the FRA Website. #### **RPNW Rex Faubion Briefing on the NWR and National NBOD Actions**

#### NWR Update:

- Bremerton Branch 29 and Silverdale Branch 310 have merged.
- Anchorage Branch 342 is still conversing on voluntarily surrendering their Charter.
- Whidbey Island Branch 97 is still in their reconstruction mode after the fire they had during the first year of COVID. They should be back to full operation in the Spring of 2024.
- There were 53 essays judged at the Branch level. Twenty (20) essays were received for judging a the Region level. The next week will be the judging of these 20 essays and the first place winners will be forwarded to national for the final judging.
- Membership is struggling. NW lost 15 members in the month of January that were terminated for Nonpayment of dues.
- A Zoom meeting is scheduled for February 12 to discuss the future of the NW LAFRA.
- We need to get everyone we can to attend the NW Region Convention in Kennewick, WA during the September 6-8, 2024 timeframe. We also need to celebrate the Centennial at the convention.

#### National Update:

- Reiterated that any resolutions for the National Convention need to be to the C&BL Committee by July 15, 2024.
- The papers for the sale of the National HQ building for \$3,970.000 have been signed. HQ is now on a lease agreement which runs until 31 August, 2024. Rent escrow of \$50,528.39 has been paid. We are paying about \$5420 monthly.
- Determination has to be made on what to do with archives, library, and artifacts.
- A lease agreement has been signed for new office space at 1600 Duke Street in Alexandria, VA.
- FRA Centennial Celebration is November 10-16, 2024 in Annapolis, MD.
- In conjunction with the Centennial, FRA is the host for the Veterans Day Ceremony at Arlington National Cemetery. This also involves sponsoring a reception for 200-300 people at Patton Hall on Ft. Meyer.
- The membership application has been updated and available on the FRA website.
- C&BL from last year's convention has been revised/corrected to reflect changes to membership.

As you can see, there has been a lot going on this year.
